## **Instructions for authors**

Manuscripts (ms) should be submitted to the Editor in Chief (bjarni@lbhi.is) in Word format with as little formatting as possible. The main text should be submitted in normal A4 format, using Arial 11 font size and without splitting words.

The language and content should be ready for publication, checked for errors including linguistic errors, before submission. Manuscripts should be in English with an English abstract.

An editorial committee member and an external peer will review the ms and possibly ask for some modification before the ms will be transferred into a professional layout program for on-line publication in the journal.

On the first page of the ms write the title of the paper and authors name(s) accompanied with the authors' correspondence address.

The manuscript should preferably be split up into the following sections: Abstract, Introduction, Material and methods, Results, Discussion, (Acknowledgements) and References.

Figures and tables should be numbered with arabic numbers and referred to in the text as "Fig. 3" or "Table 3". Text for figures and tables should be full and complete and readable without reference to the text. Legends on graphs should be Arial 11 p.

Place the figures and tables furthest back in the manuscript, but indicate where you would like their placement in the ms by locating [Fig. x; Table x] at the right place.

Figures should be designed to fit one (8 cm) or two (16 cm) column widths, with a maximum height of 19.6 cm. Figures should be submitted at the size

they are to appear in the journal. Please check that when reproduced at final size, lettering on figures and tables are of the requested size (Arial 11 p).

References in the text should be as follows: (Hancock & Simpson 1962, Hawkins 1987, Santelices *et al.* 1995) and should be written in the following style in the reference list:

> Santelices, B., A.J. Hofmann, D. Aedo, M. Bobadilla & R. Otaiza, 1995. A bank of microscopic forms on disturbed boulders and stones in tide pools. Mar. Ecol. Progr. Ser. 129, 215-228. https://doi.org/...

The SI-units should be used throughout when reporting on measurements.

Latin names of organisms should be in italics and followed by the proper author names the first time they are mentioned in the text.

A Word file containing text, tables and figures should be sent to the Editor in Chief. If using photographs, please also submit those as a separate jpg files in 600 dpi resolution.
